Eligibility-Open to all artist, 18 years or older. Drawings, paintings and sculpture, works no larger than 36" in either direction. No wet paintings. Sculpture may not weigh more than 40 pounds and limited to 36" in either direction. Prints, photographs or any computer generated arts are not eligible for this exhibit. All work must be original, completed within the last 2 years and not shown in a previous Regional Juried Art Show or in TFAC Gallery 1. Works to be hung must be wired and ready for hanging. No sawtooth hangers. Watercolors must be under glass or plexiglass. Accepted works must remain in the Gallery for the duration of the exhibit.

Entry must be hand delivered and accompanied by the following:

1. Entry form and fee: \$25.00
2. Self-addressed stamped Juror's Notification
3. Identification label affixed to back upper left-hand corner of work.

Glen has a BFA from Tennessee State University and an MA in Art Education from the University of South Florida and further graduate study in drawing and painting through the University of Tennessee. Glen has been a public high school art teacher for 16 years and currently teaches at Converse College and Furman University and is a member of the faculty of the Greenville County Museum of Art.
